Pursuant to NMSA 1978, § 1-8-11 to 1-8-52 (1969, as amended through 2021), I, Amanda López Askin, Ph.D., Doña Ana County Clerk, by virtue of the authority vested in me, do hereby issue the following notice of election;

That the Primary Election is called to be held throughout the county of Doña Ana and precincts thereof on June 4, 2024, for the nomination of General Election candidates; and

That the General Election is called to be held throughout the county of Doña Ana and precincts thereof on November 5, 2024; and

That the Primary Election shall be applicable to the following political parties; the Democratic Party, the Republican Party, and the Libertarian Party to nominate candidates for the following offices:

FEDERAL ABSENTEE

April 20, 2024 through June 4, 2024

Federal applications for an absentee ballot must be received by the County Clerk on or before May 21, 2024 (ballots being sent via USPS).

Federal applications for an absentee ballot must be received by the County Clerk on or before June 1, 2024 (ballots being sent via e-mail).

Mailing of Federal Ballots begins April 20, 2024.

Federal Absentee Ballots must be received by the County Clerk no later than June 4, 2024 at 7:00 pm.

ABSENTEE

May 7, 2024 through June 4, 2024

Applications for an absentee ballot must be received by the County Clerk on or before May 21, 2024.

Mailing of absentee ballots begins May 7, 2024.

Absentee ballots must be received by the County Clerk no later than June 4, 2024 at 7:00 pm.

Absentee ballots may be returned by mail or in person, by the following individuals: the voter, a member of the voter's immediate family/household, a voter's caregiver, or a person with whom the voter has a continuing personal relationship. Per state statute, "immediate family" is defined as a spouse, children, parents, or siblings of the voter. There is a space on the ballot envelope where a person returning an envelope must indicate their relationship to the voter.

Processing of absentee ballots will take place at the Doña Ana County Clerk's Bureau of Elections Warehouse located at 2480 Lakeside Dr., Las Cruces, NM 88007.

SECURED CONTAINER BALLOT BOXES

The Doña Ana County Clerk's Office will have 24-hour, video-monitored secured containers available to voters for the return of absentee ballots during the 2024 Primary Election.

Collections from the containers will be conducted in compliance with state statute and state administrative code at approximately 7:00 pm every 72 hours, beginning May 7, 2024.
